TERMS OF REFERENCE

Background:

Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is a German Government enterprise that provides services in the field of international development cooperation worldwide. In India, GIZ has been working jointly with partners for sustainable economic, ecological and social development since more than 60 years now.

The “Indo-German Support project for climate action in India” project in partnership with the “Strategic Partnerships for the Implementation of the Paris Agreement” (SPIPA) is supporting the state governments of Gujarat and Haryana in setting up climate change learning labs at Nature camping site, Thapli, Haryana and Science city, Ahmedabad, Gujarat. This learning lab will have a modern learning environment on climate change, and interactive spaces.

The Learning Lab offers a unique opportunity of experiential learning. As a learning centre where innovative instruments explore topics like climate change and climate finance, it will contribute to the sustainable competence development of target groups on these topics. Furthermore, the Learning Lab will also enable relevant target groups to access national and international climate financing sources to address issues related to climate change. In other words, let trainees discover what climate finance is about, and further encourage initiatives and actions at each individual or group level. The lab can be used both, for self-paced learning and training activities.

Key outputs are knowledge exchange among various stakeholders in an interesting, interactive, and experiential manner which will have an impact on Widespread public awareness on climate change among various groups and enhancement of the learning process and the involvement of different stakeholders in climate action.

Present Scenario

The proposed Climate Change Learning Lab in Gujarat is located at the Science city campus at Ahmedabad. The proposed climate change learning lab in Haryana is located at the nature camping site, Thapli, Haryana.

The Learning Lab will provide the information on the basics of Climate science, Vulnerability to climate change and potential solutions. The components of the climate change learning lab are broadly as follows:

- Basics of Climate Change
- Impacts of Climate Change
- Understanding Climate Change Vulnerability
- Concept of Carbon Footprint
- Concept of Handprint
- Climate Change Mitigation and Adaptation
- Capacity Building & Research Support

Purpose of the Tender

GIZ India would like to procure IT and Electronics equipment as per the terms of reference. The interested bidders must undertake the task of supply of equipment for Climate Change Learning Lab at Nature camping site, Thapli, Haryana and Science city, Ahmedabad, Gujarat

The selected bidder shall make available the required equipment as specified in Annexure

The responsibility of installation, transportation, loading and unloading including transit insurance of equipment till handing over to the end-user shall be with the selected bidder.

- The site is located at Nature camping site, Thapli, Haryana and Science city, Ahmedabad, Gujarat. The address of the site shall be provided by GIZ whereas the shipment of the equipment is arranged by the bidder assuring a safe transportation.
- Transportation/Shipping of equipment shall be in coordination with the designated GIZ officer.
- At the site, the selected bidder shall unpack the box in presence of nodal official or GIZ representative in charge of the site and check the equipment as per the equipment specifications/manual.
- The bidder should clearly mention in the proposal, about the warranty/guarantee for each equipment(s).
- **Specifications:** The equipments will be installed as per the specifications. However, any change found essential to coordinate the installation of this work with other trades will be made without any additional cost to the GIZ wherever possible or an approval will be taken from GIZ.
- **Materials & Equipment:** All materials and equipment will conform to the relevant Indian Standards and will be of the approved make and design. Contractor will be responsible for the safe custody of all materials and will insure them against theft or damage in handling or storage etc (if required).
- **Completion Certificate:** On completion, a certificate will be furnished by the Contractor countersigned by the supervisor, under whose direct supervision the installation was carried out.

Liquidated Damages and Termination of Contract

Except because of force majeure, if the bidder fails to perform the scope of work, to the satisfaction of GIZ, within the time period specified in the delivery schedule or within the extended time period if any, GIZ shall without prejudice to its other remedies under the contract, deduct from the contract price as liquidated damage, a sum equivalent to 1% of the price of the un-performed work/ services for each week of delay until actual completion of work, up to a maximum deduction of 10%. Once the maximum is reached GIZ may consider termination of the contract.

Force Majeure

Force Majeure Events shall include the following events to the extent they satisfy the foregoing requirements:

- Natural disasters, including but not limited to lightning, earthquake, volcanic eruption, landslide, flood, cyclone, typhoon, tornado
- any act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, blockade, embargo, revolution, riot, insurrection, terrorist or military action
- any requirement, action or omission to act pursuant to any judgment or order of any court or judicial authority or Statutory Entity in India of any Law or any of their respective obligations under this Agreement
- expropriation and/or compulsory acquisition of the Project in whole or in part by any Government or Statutory Entity
- radioactive contamination or ionising radiation originating from a source in India or resulting from another Force Majeure Event excluding circumstances where the source or cause of contamination or radiation is brought or has been brought into or near the Project Site by the Affected Party or those employed or engaged by the Affected Party
- industry wide strikes and labour disturbances having a nationwide impact in India

Force Majeure Event shall not include the following conditions, except to the extent that they are consequences of a Force Majeure Event:

- unavailability, late delivery or change in cost of steel, equipment, materials, spares parts or consumables in local market
- delay in performance of any contractor or sub-contractor or their agents
- non-performance resulting from normal wear and tear of plant, materials or equipment at the bidders facility
- strike or labour disturbances at the facilities of the bidder
- insufficiency of finances or funds or the agreement becoming onerous to perform
- non-performance caused by, or concerned with, the bidder negligent and
- intentional acts, errors or omissions
- failure to comply with Law, or
- breach of, or default under this Agreement.

Payment Terms

- upto max. 30% of bid price as advance after signing the order and after submission of bank guarantee with a validity of minimum 90 days from the date of signing the PO.
- 60% after complete delivery of material at site.
- 10% after complete Installation/testing/commissioning of material at site.

Payment will be made in 10 working days after receipt of original invoice, delivery challan, installation report at GIZ Office, New Delhi

Delivery of Material

The Bidder should note that it has to furnish and agree with GIZ, the delivery of the material at the project site (Annexure – F)

The equipment delivery must be coordinated with GIZ before dispatch to the project site.

 2. Company's statutory Compliances like Annual Turnover, GST, PAN, Client List etc.
 3. Techno-Commercial Proposal must be duly signed and stamped and should clearly mention the following;
